#### <u>INSTRUCTIONS TO TENDERERS</u>

- (1) Printed tender forms can be obtained from the office of the undersigned. Tenders submitted not in such printed forms or tenders, incomplete in any respect such as unattested errors and corrections etc will be liable for summary rejection.
- (2) No tenders received after the specified last date and time will be accepted on any account.
- Details of the work with item wise specifications and rate are given in the subjoined (3) schedule of work. Tenderers must quote only a single rate as an overall percentage above / below / at the rate given in the schedule of work, by a single entry at the hottom of the schedule of work under the head 'quoted rate' by scoring out the and attesting all corrections. The rates quoted shall be inclusive irrelevant parts ones covering all the operations contemplated in the schedule of works and all incidental works necessary for such operations. The overall percentage rate quoted shall not be varied on any account whatever and it shall hold good for all items of work done, irrespective of variations of quantity if any.
- (4) Each tenderer should submit along with the tender a signed copy of document in proof of his registration in Kerala PWD as contractor of the class prescribed in the notice inviting tender.
- (5) Each tender should be accompanied by an Earnest Money Deposit of amount mentioned in the notice inviting tender. EMD can be produced in one or other of the following forms
  - a. Demand Draft on a Scheduled Bank drawn in favour of the officer who has invited tenders.

- (6) In consideration of the tenderer being allowed to quote for the work, he should keep the tender firm for a period of four months from the last date for the submission of tenders. Withdrawal of tenders before this period will entail forfeiture of EMD for the work.
- (7) The acceptance of the tender rests with the officer inviting tenders who does not undertake to accept the lowest or any particular tender.
- (8) The EMD of unsuccessful tenderers will be refunded as soon as possible after tabulating the tenders, keeping the EMD of the first three lowest tenderers. EMD of the remaining unsuccessful tenderers will be refunded within a week of acceptance of the successful tender.

- (9) The successful tenderer within seven days of receipt of the selection notice shall deposit an amount which along with the EMD shall make up the total amount equal to 3 % of contract amount (limited to a maximum of Rs1,00,000/-)which shall be treated as Security Deposit for the proper fulfillment of the work and he shall also execute an agreement for the work in the standard format.

If any extra items of work not included in the schedule are executed, its rates will be arrived at on the basis of the rules followed in Kerala PWD.
- (13) Time is the essence of the contract. The work shall be completed within ................................. months from the date of receipt of written order to commence the work. If the work is not completed by the agreed date liquidated damages will be recovered from the contractor in accordance with the conditions of contract.
- (14) Contractor shall appoint qualified engineering representative at site to supervise the work.
